**DEPOSIT:** \$100 non refundable deposit and contract is required to reserve and hold date. Deposits And contract can be mailed, OR deposit paid through paypal and contract faxed or scanned.

**CONTRACTED DATE:** You may cancel this contract at any time up to 2 weeks before the date of service and only loose deposit. After that, you will be charged 50% of the quoted rate. If you cancel within 48hrs prior to service date, you will be charged 100% of the quoted rate. This contract is non-negotiable.
